

Morpheus Terms and Conditions

These Terms and Conditions apply to the entire contents of Morpheus website under the domain name <https://morpheus.digital/> ("Website") and to any correspondence by email between Morpheus and its group companies ("Morpheus", "us" or "we") and the user/site visitor ("you" or "User"), and shall govern the use of Morpheus websites, applications, products and services, as well as any sale and purchase of Website services therein (herein "Services").

Please read the following terms and conditions carefully before using this Website. Using this Website indicates that you accept these terms regardless of whether or not you choose to register with us. If you do not accept these terms, do not use this Website.

1. DEFINITIONS

"Ad Network Terms" means all terms, conditions, and/or policies applicable to any advertising activities on or in connection with any third-party advertising network which you intend to place advertisements at or have otherwise integrated.

"User" shall include employees that you have expressly authorized to use and access the Morpheus Platform through your Morpheus account.

"Due Diligence Requirements" means requirements imposed by Law that govern, are related to, or are similar to Anti-Money Laundering (AML), Know Your Customer (KYC), Know Your Business (KYB).

"Personal account (user account)" – within the framework of these Terms and Conditions, the user's personal account on the Website, which is available to him after registration on the Website.

"your Data" means advertising campaign data or information made available to Morpheus or the Morpheus Platform by or on behalf of you or any User or via use of the Morpheus Platform by you.

2. MORPHEUS' OVERVIEW

Morpheus and its affiliates provide users with various authorized channel platforms through the Internet, such as Facebook, Google, YouTube, BigoAds, Tiktok and other channel platforms ("Platforms").

3. USE OF THIS WEBSITE

1. You may access most areas of this Website without registering your details with us. Certain areas of this Website are only available to you if you register.
2. By accessing any part of this Website, you shall be deemed to have accepted this legal notice in full. If you do not accept this legal notice in full, you must leave this Website immediately.
3. The Company may revise this legal notice at any time by updating this posting. You should check this Website from time to time to review the current legal notice as it is binding on you. Certain provisions of this legal notice may be superseded by expressly designated legal notices or terms located on particular pages of this Website.
4. Advertising campaigns through Morpheus Service are managed via Personal Account. Access is granted after registration on the Service and the acceptance of an appropriate service agreement, following payment under the specified agreement.

4. REGISTRATION

1. As applicable, each registration is for a single user only. The Company does not permit you to share your user name and password with any other person nor with multiple users on a network.
2. Responsibility for the security of any passwords issued rests with you.
3. All information provided by you during the registration process must be accurate and true.
4. Registration takes place on the main page of the Website:

after clicking the "Register" button, an email from [redacted] is sent to the email specified by the User, containing the login (email), the password generated for the account and a link to the

personal account.

5. The User is solely responsible for the safety of his login and password from his personal account.

All actions on the Website performed under the User's login are recognized as committed by the User.

6. After registration, the User gets the opportunity to use the Service for introductory purposes, without the possibility of managing advertising campaigns.

5. AML/KYC/KYB Policy.

This section and policies published at the Website confirm Morpheus's commitment to prevent money-laundering and the financing of terrorism in its business practices and transactions.

Morpheus has established Know Your Counterparty (KYC) and Know Your Business (KYB) procedures to combat money laundering and the financing of terrorism. These procedures allow us to identify every individual and/or organization that we deal with, to understand the legitimacy of our business relationships and to identify and react to unusual or suspicious activity.

6. FEES & Payment Terms.

By agreeing to the Terms & Conditions you hereby undertake to pay Fees for the provision of Services either: (i) in advance with the first payment; (ii) by the means of deferred payment. All payments due to Morpheus under these Terms & Conditions shall be made by bank wire transfer in immediately available funds to an account designated by Morpheus, debit cards or credit cards in the currency designated by Morpheus. All prices are in US Dollars and EUR only. You further agree that if your charge is later declined or reversed for any reason, you shall be responsible to Morpheus for the full Fee payment, along with any interest or other charges incurred by Morpheus in connection with the decline or reversal of the credit card charges.

Morpheus shall not be liable to you if a transaction is not completed due to any limits on the use of your credit card, debit card or electronic funds transfer due to your agreement with your financial institution or by applicable law, or if a financial institution fails to honor any credit or debit purchase.

You are responsible for any Taxes, and will pay Morpheus for the Services without any reduction for Taxes. If Morpheus is obligated to collect or pay any Taxes, the Taxes will be invoiced to you and you will pay such Taxes to Morpheus, unless you provide Morpheus with a timely and valid tax exemption certificate in respect of those Taxes.

You will provide Morpheus with any applicable tax identification information that Morpheus may require under applicable law to ensure its compliance with applicable tax regulations and authorities in applicable jurisdictions. You will be liable to pay (or reimburse Morpheus for) any taxes, interest, penalties, or fines arising out of any mis-declaration by Customer.

1. The User is not provided with guarantees of achieving any goals through the use of the Service. Morpheus shall not be held responsible if the Service does not meet the expectations of the User. 8. Indemnification

You hereby agree to defend, indemnify and hold Morpheus harmless, its affiliates and their respective officers, directors, shareholders, employees, contractors, agents, licensors, service providers, successors and assigns from and against any claims, judgments, awards, losses, liabilities, expenses, damages, costs, fines, penalties and fees (including reasonable attorneys' and experts' fees and court costs) (collectively, "Losses") arising out of or relating to (i) your use of the Website or its Content other than as expressly authorized in these Terms and Conditions; (ii) claims arising from your fraud, intentional misconduct, criminal acts or gross negligence. If you cause a technical disruption of the Site or the systems transmitting the Site to you or others, you agree to be responsible for any and all Losses arising or resulting from that disruption.

8. Intellectual property
